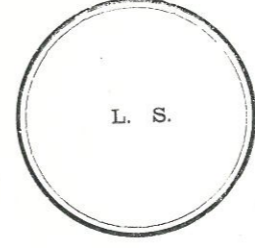

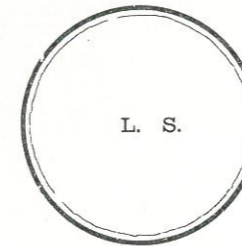

NOW THEREFORE the Minister, in pursuance of the powers in the said Order recited, does hereby confirm the said Order.

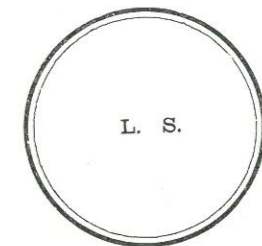
THE said Order may be cited as the River Welland Catchment Board (Deeping Fen, Spalding and Pinchbeck Internal Drainage District) Order, 1939."

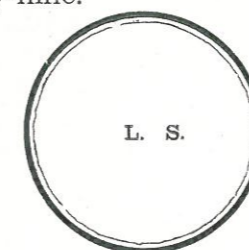
