THE RIVER WELLAND CATCHMENT BOARD (ADDITION OF BOURNE AND THURLBY INTERNAL DRAINAGE DISTRICT TO THE DEEPING FEN, SPALDING AND PINCHBECK INTERNAL DRAINAGE DISTRICT) ORDER, 1943, CONFIRMED APRIL 1, 1943, BY THE MINISTER OF AGRICULTURE AND FISHERIES UNDER THE LAND DRAINAGE ACT, 1930 (20 & 21 GEO. 5. C. 44).

1. The Minister of Agriculture and Fisheries (in this Order called the Minister) in exercise of the powers conferred upon him by the Land Drainage Act, 1930, and of all other powers enabling him in that behalf, hereby confirms the scheme for the addition of the Bourne and Thurlby Internal Drainage District, to the Deeping Fen, Spalding and Pinchbeck Internal Drainage District, submitted to him by the River Welland Catchment Board under Section 4 (1) (b) of the said Act, a copy of which Scheme is annexed hereto, with the following modification (which has been incorporated in the Scheme) that is to say:—

Paragraph 1—4th line. After the word "green" and before the words "on the map" the words "and red" have been deleted.

2. For the purposes of this Order and the Scheme annexed hereto the area to be added to the Deeping Fen, Spalding and Pinchbeck Internal Drainage District shall be the area coloured green on the map prepared by the Minister on the 6" Scale and sealed by him in relation to this Order; and the said map on the 6" Scale shall for such purposes be substituted for the map referred to in paragraph 1 of the Scheme.

3. The Minister hereby appoints Ernest Harold Ward, Esquire, of The Manor House, Thurlby, Bourne; Everitt Delanoix Cooke, Esquire, of Austerby, Bourne; and Robert Phillip Watts, Esquire, of Vine House, Deeping St. Nicholas, Spalding, to be the three additional members of the Deeping Fen, Spalding, and Pinchbeck Internal Drainage Board to represent Electoral District E of the existing Internal Drainage District.

4. The expenses of the Minister in connection with the making and confirmation of this Order shall be borne by the Catchment Board and shall be part of the administrative expenses of the Catchment Board.

LAND DRAINAGE ACT, 1930.

20 AND 21 GEO. V. CH. 44.

To the Right Honourable

The Minister of Agriculture and Fisheries,

Scheme proposed by the River Welland Catchment Board in pursuance of
Section 4 (1) (b) of the Act.

The following Scheme is respectfully submitted to the Minister of Agriculture and Fisheries in obedience to the directions of Section 4 of the Land Drainage Act, 1930, making provision for certain matters mentioned in the said section and is supplemental to a Scheme setting up the Deeping Fen, Spalding and Pinchbeck Internal Drainage Board which came into force on the 1st day of April, 1939, viz.:—

1. The addition to the Deeping Fen, Spalding and Pinchbeck Internal Drainage District of the District heretofore known as the Bourne and Thurlby Internal Drainage District coloured green on the map attached to this scheme.

2. The abolition of the Bourne and Thurlby Internal Drainage Board and the transfer of the rights, powers, duties, obligations, liabilities and property of the said Board to the Deeping Fen, Spalding and Pinchbeck Internal Drainage Board.

3. Certain matters supplemental thereto and consequent thereon.

And the Catchment Board submit the Scheme to the Minister of Agriculture and Fisheries for confirmation under Section 4 of the Act.

S C H E M E.

As from a day (hereinafter called "the appointed day") to be appointed by the Minister of Agriculture and Fisheries, the following provisions shall have effect:—

1. There shall be added to and included in the Deeping Fen, Spalding and Pinchbeck Internal Drainage District (hereinafter called "the Deeping Fen District") the lands coloured green on the map sealed by the Catchment Board in relation to this scheme.

2. The number of members of the Deeping Fen, Spalding and Pinchbeck Internal Drainage Board (hereinafter called "the Deeping Fen Board") shall be increased to 19 and three additional members, with the exception of the first members, shall be elected in accordance with Section 33 of and the Third Schedule to the Land Drainage Act, 1930. The first additional members shall be appointed by the Minister of Agriculture and Fisheries and shall hold office until the expiration of the term of office of the present members of the Deeping Fen Board.

3. The Electoral Divisions into which the Deeping Fen District is divided by Clause 6 of the original Scheme setting up the Deeping Fen Board as delineated on the Key Map annexed to the 6 inch Map sealed by the Catchment Board in relation to that Scheme shall be increased to 5 and the number

of members by which the additional division shall be represented on the said Deeping Fen Board shall be as follows:—

4. The Bourne and Thurlby Internal Drainage Board set up by the Order referred to in the Schedule hereto shall be abolished.

5. All property, rights, powers, duties, obligations and liabilities vested in or to be discharged by the Bourne and Thurlby Internal Drainage Board on the appointed day shall be transferred to the Deeping Fen Board.

6. The power to collect all rents due to and all rates (including arrears of rates) already made by the Bourne and Thurlby Internal Drainage Board in respect of any lands in the Deeping Fen District and not collected by the appointed day together with the powers and duties of the Drainage Boards in relation thereto shall be transferred to the Deeping Fen Board.

THE SCHEDULE ABOVE REFERRED TO.

Scheme made by the River Welland Catchment Board under Section 4 (1) (b) of the Land Drainage Act, 1930, dated the 29th day of January, 1940, and confirmed by the Minister of Agriculture and Fisheries on the 30th day of June, 1941.

The Seal of the River Welland Catchment Board was hereunto affixed this Eleventh day of August, 1942, in the presence of:—
